Part 1

Part 2

Abstract :

Finwiz: The Finance club of RDIAS organized an event called “**Fun with Finance**” for the students of MBA on August 30, 2018 from 11:00 AM to 1:00 PM in LAB-3, B-Block. This activity was held for the students so that they can enhance their knowledge and skills. Total students who enthusiastically participated in the event were 48, divided into 24 teams consisting of 2 members each.

RDIAS provided students a platform where they can showcase their knowledge and skills and also enhance them by participating in such activities. There were three rounds in the activity.

The first round was “**Rapid Fire round**”. In this round, there were 24 teams and they were given a questionnaire consisting a few questions related to finance that were to be completed within the time limit of 10 minutes. After evaluation of the sheets, 8 teams were selected for the second round.

The second round was “**Financial Term round**”. This round was a financial quiz round in which the questions were displayed on the screen and each team was given 30 seconds to answer the respective questions. In case, a team was unable to answer any of the questions, they were given an option to pass the question. There was a negative marking in this round for the teams who had given a wrong answer for passed question. From this round, only 3 teams were selected for the third and final round.

The third and final round was “**Role Play round**”. In this round, the teams were allotted topics to perform on the working environment and roles of different authorities in financial organization. They were a time limit in which they had to prepare an act and present it in front of the judges and students. The students were highly motivated which helped them bring out the best in themselves. All the students of MBA participated in the same with full zeal and enthusiasm.

The event was judged by an internal member, Ms. Supriya Sardana who is a faculty (Finance) at RDIAS and an external member **Mr. Ravi Sharma (Founder and Director of Visok Advisors Pvt. Ltd.)**. Ravi Sharma has been a financial advisor for more than 10 years now and has a rich experience in the financial industry. He has worked with companies like Aditya Birla Money - Wealth Management, Future General India Life Insurance, ICICI Prudential Life Insurance etc. He also has an experience of working with First Gulf Bank – Wealth Management, where he managed assets worth millions. He addressed the students by sharing his experiences and making the students

learn about the practical situations and environment in the finance industry.
